

HOW HAS THE COVID-19 PANDEMIC CHANGED THE LANDSCAPE OF DISTANCE **EDUCATION?**

The COVID-19 pandemic shifted many postsecondary courses online due to public health concerns. For some students, this may be their first time participating in distance learning.

Distance learning in 2020

of students have reported that they will be receiving their instruction fully online in Fall 2020

of colleges have planned to be fully online



a majority

of students stated that they will receive instruction through a "hybrid model" partially online, partially offline.9



have had a primarily online or hybrid model this fall with less than a quarter of colleges with instruction primarily in-person.¹⁰

Looking ahead to spring, colleges are generally planning for more of the same, with most schools indicating they will have online or hybrid instruction.

As more students shift to distance education throughout the COVID-19 pandemic and beyond, policy and practice should anticipate the needs of students who continue to learn online at greater numbers. Broadband access and affordability remains paramount to online learners, and off-campus or local child care can be a reliable option instead of campus-based. As our postsecondary learning system continues to evolve, we must continue to support student success, no matter where it occurs.
